Subject: Financial Sanctions of Comprehensive Incentive Package for ASHA under State Budget 2013-14

Reference to the subject noted above.

This is in compliance of Govt. of Haryana Memo No 23/09/2014-4HBIII; Dated 17/02/2014 regarding Comprehensive Incentive Package for ASHA under State Budget in addition to their existing performance based incentives under NHM, who are the Volunteers and Financial Sanctions are accorded as under:

In above references, it is further clarified that

- Sr. No. 1 and 2 shall be applicable w.e.f. 01/02/2014, for all such ASHAs, who are active as per the ASHA Master Chart of January 2014 and Sr. No. 3 will be applicable w.e.f. April 2013 (As per Annexure-I, which is based on the ASHA Master Chart February 2014).
- The dormant ASHA (i.e. Zero Performing ASHA upto February 2014) shall not be entitled for these incentives and as soon as Zero Performing ASHA starts earning under NHM, she will be entitled for fixed incentive.
- Although, new ASHA (i.e. who has been enrolled in January 2014 but not earned any incentive during the month of February 2014) will be entitled for these incentive. Such ASHAs will be treated at par with other ASHA w.e.f. March 2014 onwards.

The fund for additional incentives as referred above is being transferred to your account, separately. In the mean time, payment to ASHA may be made from NHM budget. You are required to keep separate records for the above referred incentive payments to be made to ASHA for audit purpose and the same are required to be mentioned in the forthcoming ASHA Master Chart. The utilized amount under State Budget for comprehensive incentives for ASHA is also required to be booked under FMR No. X.1, X.2 and X.3 respectively.
