Subject:- Regarding complete ban on the recruitment of staff under NHM.

Please refer to the subject cited above.

In continuation to this office letter No. MD/NHM/2015/2586 dated 9.4.2015 vide which you were requested "No advertisement may be made until all the excess staff has been adjusted".

Now it has also been decided to ban on the recruitment of staff (except MOs and Specialists) in all National Programmes including disease control programme and other programmes under the umbrella of NHM. In case of dire need, a special approval of MD (NHM) may be sought. The same will also be applied on the enrollment of ASHAs in rural as well as urban areas till further order.

This will supersede all earlier sanctions issued earlier under various schemes. You may personally ensure the compliance of these instructions and also issued vide letter MD/NHM/2015/2586 dated 9.4.2015.
